WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Desktop Computers for the College of Computer Studies (APP 2024), Rebid with an Approved Budget for the Contract (ABC) of ₱ 1,800,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on November 14, 2024;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University BAC Conference Room and webcasted via Zoom on November 22, 2024;

WHEREAS, in the public bidding held at the TSU-BAC Conference Room on December 04, 2024, at 2:00 P.M.:

- (a) two bidders, namely, Xymbolic IT Solutions Provider Corporation, and Infoworx Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Xymbolic IT Solutions Provider Corporation and Infoworx Inc. contained all the required documents and were rated "passed",
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the two bidders and found that the envelopes of the two bidders contained the prescribed documents and were rated "passed";
- (d) the BAC resolved to declare Infoworx, Inc., as the bidder with the Lowest Calculated Bid with the bid amount of 1,740,000.00,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the and Lowest Calculated Bid;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on January 10, 2025:

- (a) the TWG for Financial and Legal Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspects reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents,
- (c) the BAC deliberated the TWG reports, and unanimously agreed to declare the bid of Infoworx, Inc., as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Infoworx, Inc., as the bidder with the Lowest Calculated and Responsive Bid (LCRB), with the bid amount of One Million Seven Hundred Forty Thousand Pesos (1,740,000.00), and,
- (b) to recommend to the President the Award of Contract for the project, Supply and Delivery of Desktop Computers for the College of Computer Studies (APP 2024), Rebid to Infoworx, Inc.
